Pursuant to art. 13 of Regulation EU 2016/679**

This document contains important information on the personal information that will be processed by **Agras Delic S.p.A. di unico socio** when browsing this Internet site.

The information should be read carefully before sending any type of personal information and/or filling out any electronic form on the site www.stuzzycatanddog.com and is provided pursuant to art. 13 of Regulation EU 2016/679 (GDPR) solely for this site (it is not valid for other websites that the user may browse via its links).

A) Processing Controller

The processing controller is Agras Delic S.p.A. di unico socio, with registered address Viale Bianca Maria 25, Milan and operating site at Via S. Vincenzo, 4, Genoa, VAT no. 03765340967 (subsequently "Agras Delic").

B) Personal data collected

B.1.) Browsing data

The computer systems and software procedures used for the website to function acquire certain personal data during their normal operation, the transmission of which is implicit when using Internet communication protocols. This includes IP (*Internet Protocol*) addresses and domain names of computers used by users connecting to the website, URI (Uniform Resource Identifier) addresses of the resources requested, the time of the request, the size of the file obtained in response, the numeric code indicating the status of the response given by the server and other parameters relating to the user's computer environment and operating system. The sole purpose of the collection of this data is to obtain anonymous statistical data on the use of the website and to ensure that it functions correctly. The data could be used to check for liability in the case of possible computer crimes affecting the website.

B.2) Data supplied voluntarily by the user/visitor

Voluntary granting of personal data to Agras Delic (including via email messages) implies subsequent acquisition of the same data, necessary for responding to your requests and/or establishing negotiations and contractual relationships with you.

B.3) Cookies

C) Legal basis and purposes of processing

Your personal data will be processed by Agras Delic for one of the following purposes:

1. **Allowing you to complete your registration with the Internet site**
2. **Executing contractual relationships**
3. **Opening and entering into pre-contractual relationships**

In these three cases the processing of your personal data has a legal basis in your request and in the pre-contractual or contractual relationship that you intend to open with Agras Delic. In the absence of such data it is not possible to proceed with the processing and, consequently, complete your registration with the site, or establish pre-contractual or contractual relationships.

4. Involving you in promotional and/or marketing activities

Your consent is necessary in order to permit such additional data processing activities to be carried out. Your consent is voluntary, without it Agras Delic will not be able to carry out marketing activities involving your information.

D) Methods and duration of processing

The data acquired are processed by Agras Delic according to the principles of lawfulness, accuracy, transparency, limitation of purposes and storage, minimisation of data, exactness, integrity and confidentiality.

The processing is performed using electronic means and/or on paper with the use of safety measures for guaranteeing the confidentiality of your personal data and avoiding undue access by unauthorised persons.

Your personal data will be processed for the entire duration of the relationship with Agras Delic and, if cancelled, for an additional period of 10 years, which is also to comply with legal obligations. At the end of this period, Agras Delic will delete your personal data.

E) Categories of recipients

To carry out correctly all processing activities necessary for pursuing the purposes of this information, the following recipients may process your personal data:

- Employees of Agras Delic who are assigned the processing of your personal data. These individuals are given specific instructions on security and the correct use of your personal data.
- Third parties to carry out activities instrumental to that of Agras Delic, which are appointed as processing managers.

F) Rights of the person concerned

You have the right to request Agras Delic to grant access to, adjust or delete your personal data at any time, and in the presence of the legal conditions, and also to revoke your consent or limit the processing. You may also oppose the processing and benefit from the portability of your data.

Should you believe that your data has been processed in violation of the law, you may make a complaint to the Garante per la Protezione dei dati personali [Personal data protection agency].
